Bidding will be conducted through Rule XVI -Alternative Methods of Procurement under Section 53.9–Negotiated Procurement – Small Value Procurement, pursuant to the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable contractor with good performance record.

To bid for this contract, a contractor must have a Net Financial Contracting Capacity (NFCC) at least equal to ABC and submit the Original Receipt (OR) for payment of bidding documents before dropping of bids. Submission of Bid Security may be dispensed with (non-required) as provided for in Section 54.4 of the 2016 Revised IRR of RA 9184. **Bidders shall likewise submit their bids through their duly Authorized Liaison Officers (with valid ID) as listed in the Contractor’s Information (CI) of their CRC.**

A complete set of Bidding Documents may be purchased from the BAC Office upon payment of a non-refundable fee for the Bidding Documents in the amount *stated above*. **Bidders can make payments for the purchase of the Bidding Documents at any DPWH field offices.** It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement system (PhilGEPs) and the website of the Procuring Entity, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Contractor who will submit the Lowest Calculated Bid/Quotation will be considered for Bid Evaluation and Post Qualification, in accordance with Sections 32 and 34 of the 2016 Revised IRR of R.A. 9184.

Bids must be delivered at BAC Office, DPWH Regional Office VIII and will be opened in the presence of the bidders' representatives who choose to attend. Bids received in excess of the ABC shall be declared non-complying/failed. Late bids shall not be accepted.

The **DPWH Regional Office No. VIII, Baras, Palo, Leyte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract, without incurring any liability or obligation to the affected bidders, in accordance with the provisions of Section 41 of 2016 Revised IRR of R.A No. 9184.

Prospective Bidders/Contractors are strictly advised to observed COVID-19 health protocols prescribed by the IATF for COVID-19 and/or Local Government Units, and thus, they and/or their Authorized Representative who will attend the procurement activities and submit bids are required to present current "Health Certificate" issued by their respective Rural Health Unit (RHU) Physician and submit for self-quarantine whenever necessary.
