APPROPRIATION ORDINANCE NO. 01-2022

Introduced by: HON. AMELITA B. ECHUAL & HON. JOUIE P. TIU and BODY

AN ORDINANCE APPROPRIATING THE LUMP SUM AMOUNT OF TWO HUNDRED SEVENTY NINE MILLION, TWO HUNDRED NINETY THREE THOUSAND, FOUR HUNDRED TWENTY FOUR PESOS AND 99/100 (**P**279,293,424.99) COVERING THE C.Y. 2022 ANNUAL BUDGET OF THE MUNICIPALITY OF STA. RITA, SAMAR

Be it enacted by the Sangguniang Bayan in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be called "CALENDAR YEAR 2022 ANNUAL BUDGET OF THE MUNICIPALITY OF STA. RITA, SAMAR".

SECTION 2. ESTIMATED REVENUE. The estimated revenue of the Municipality of Sta. Rita, Samar for the Calendar Year 2018 are as follows:

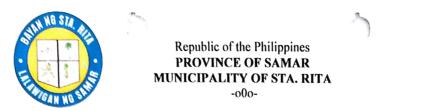
